## **U.S. Senator Thom Tillis** Visits Kings Mountain

## Leaders discussed the importance of lithium to U.S. national security and the need for a resilient domestic supply chain

Sen. Thom Tillis, R-N.C. recently visited the Kings Mountain site as part of a statewide tour during Congress' summer recess. In addition to getting a firsthand view of the entire lithium ecosystem that the Kings Mountain site affords, Sen. Tillis met with Albemarle's Energy Storage President, Eric Norris, Chief Technology Officer, Glen Merfeld and Senior Mining Director, Matt Hastings.

The minerals sector is a priority for the senator, especially given North Carolina's large role in upstream and midstream portions of the lithium supply chain. Sen. Tillis is a cosponsor of the recently introduced **Global Strategy for Securing Critical Minerals Act**. He was also one of 19 Republican senators to vote in favor of the Bipartisan Infrastructure Law, the historic investment undertaken by the U.S. government that provided the funds for the \$150 million Department of Energy grant awarded to the Kings Mountain Mine project in 2022.

The tour included a visit to the Kings Mountain Mine pit and the site's research and development dry room to view some of the work being conducted with advanced lithium metals.





"Albemarle's investment in Kings Mountain represents a commitment not only to North Carolina, but to securing the United States' leadership in critical mineral production," said Sen. Tillis.

## **Safety is the Top Priority** *for Albemarle*

As the company continues to work to potentially redevelop the Kings Mountain Mine, Albemarle prioritizes safety in our design, planning and overall approach to work to mitigate potential hazards in a manner similar to how hazards are mitigated for the existing facilities at Kings Mountain. As a result, our safety record—both in environmental and occupational aspects—is considered best in class.

Specialized training programs tailored for mining employees are being created to equip them with the necessary skills to carry out their tasks safely, efficiently and consistently. Although this mining-specific program is currently under development, the program is planned to be fully established and implemented before mining operations begin at the proposed Kings Mountain Mine.

Numerous protective measures are already in use and are planned to continue once mining operations commence. At present, around-the-clock security personnel actively patrol all Albemarle properties, boundaries and assets. A network of surveillance cameras and other advanced security technologies also are used for the safety of our people and facilities.

## **Q&A with Ron Lindsey,** Albemarle's Mine Safety Manager

Ron Lindsey, Albemarle's mine safety manager, has worked in mining for over three decades. "Mining isn't dangerous —it's hazardous," Lindsey said. "We can manage the hazards. What makes it dangerous is if we don't follow the rules." During a recent interview with Ron, he was able to share insights on the importance of safety at Albemarle and the precautions employees are taking to be safe at work.

## Q: When it comes to safety, what makes Albemarle best in class?

Lindsey: Albemarle has a commitment to safety from the top down. Our leaders provide employees and contractors with tools, training, policies and site-specific guidance to keep us safe at every site. The commitment to safety from corporate is evident in everything we do, from starting every meeting with a safety share moment to conducting internal safety audits at all our sites, which result in corrective actions aimed to help us become even safer!

#### Q: Can you give a glimpse of Albemarle's safety record?

**Lindsey:** We started tracking recordable safety incidents and injuries at the Kings Mountain Mine site on July 1, 2022. Since this time, we are proud to share that we haven't had one recordable injury.

#### Q: Can you explain some of the safety procedures Albemarle has in place at Kings Mountain?

Lindsey: Permit to Work: Before any task begins, a work permit detailing the scope of work and identifying any associated hazards must be completed, signed by everyone working on the task and submitted. There are special instructions and permissions associated with certain situations, such as confined space, working at height and hot work.

Each permit is valid for only one shift. At the start of each working day, the permitting process starts again. This rigorous requirement helps to make sure employees don't become complacent with repetitive tasks. It also allows everyone to review all hazards accordingly and to make sure the scope is the same each time. Our permit to work system helps our people recognize and mitigate hazards to prevent injury.

**Incident Reporting:** We report all incidents in a computerized database. These incidents are reviewed, and corrective actions are assigned. We track all the corrective actions and follow up with the employee to make sure the corrective action has been taken.

**Stop Work Authority:** Every employee has stop work authority (SWA) if they think something poses a risk.

## Q: Where do you see growth opportunities in Albemarle's safety procedures?

**Lindsey:** I think it's important to keep advancing with the times and evolving with industry best practices and benchmarking other sites to see what they're doing well and try to incorporate these ideas into what we're doing. Just because something has worked for 20 years doesn't mean it's still the best way to do it. We never get complacent with safety.

## **Permitting** Update

After two and a half years of collecting data to support our permit applications, Albemarle has begun submitting some of the permits with local, state and federal agencies to support the redevelopment of the Kings Mountain Mine. Over the next six to 18 months, Albemarle will submit about 30 permits.

Erik Carlson, Albemarle's permitting and sustainability manager, said communication plays a large role in the permitting process. Many agencies will have a comment period, with some having hearings where people will be invited to provide oral comments. To date, Albemarle has submitted mine and water permits to the North Carolina Department of Environmental Quality (DHEQ) for the planned tailings storage facility at Archdale. The mine permit for the primary Kings Mountain site is planned to be submitted to DHEQ in September.

## **Environmental and Social Impact Assessment Update:** *Scoping Comment Period Concludes*

Albemarle is undertaking an Environmental and Social Impact Assessment (ESIA) to identify and evaluate potential impacts that may occur as a result of the Kings Mountain Mine, to further manage potential impacts and enhance benefits. A scoping report, intended to identify potential impacts for further assessment, was released for a 60-day comment period in June. The comment period is now closed, and we'd like to thank everyone who provided feedback.



## What Happens Next?

Albemarle plans to address and share comments in the final scoping report, which will be made available in October 2024.

Feedback on the scoping report has provided the ESIA team with an understanding of the community's important questions and concerns and will seek to address these through the impact assessment.

Albemarle anticipates outcomes of the impact assessment, together with proposed management measures, will be shared publicly in the first half of 2025. The draft ESIA report will be available for a 60-day comment period, supported by a series of Albemarle-hosted meetings to share our findings.
